## Certifications

## Certified Wood Sourcing

Australian Paper purchases 100% of our wood from local Victorian suppliers.

We are committed to ensuring that all our wood is from responsibly managed sources and that the areas from which we source are replanted and regrown after harvest.

Key to this commitment is our requirement for major wood suppliers to be independently third party certified. Certification is a way of demonstrating that a forest is being managed sustainably and biodiversity is maintained. Certified forestry managers are regularly audited to ensure appropriate forestry practices are in place.

Australian Paper is Chain of Custody Certified to the Program for the Endorsement of Forest Certification (PEFC™) and Forest Stewardship Council (FSC®), which are the two major global forest certification systems. Our SuperGold Sack and Bag Kraft Paper is PEFC™ certified.

## Food Contact Assurance

Australian Paper adheres to a rigorous system of control and approval of raw materials used in the production of packaging products.

SuperGold Sack and Bag Paper has been tested by an independent and accredited laboratory to confirm food compliance conformance to globally recognised standards, such as the US FDA's Packaging & Food Contact Substances Notification program and the European BfR Recommendation XXXVI on Paper and Board for Food Contact.
